REGULATION FOR MEN'S & WOMEN'S INTERCLUB 7's EVENT

STATUS OF REGULATION

This Regulation is to be read in conjunction with Regulation 8 and the clauses below replace and supersede those corresponding clauses in Regulation 8 accordingly. This Regulation applies to all Players and Clubs participating in the Tournament.

COMPETITION FORMAT

- Bowls Counties Manukau 2010 Inc. shall conduct competitions for each gender (male and female) that allow all Clubs within their Centre to enter a side(s) in the Tournament.
- The event is scheduled to allow clubs to enter teams in an Inter Club competition with the winner of each gender becoming eligible to enter the Bowls New Zealand National Interclub event.
- A club is allowed to enter one men's and one women's team of seven (7) players in this competition.

TOURNAMENT WINNER

In all games two points will be awarded for each game won. One point will be awarded for each game drawn. Two match points will be awarded for a match won

and one point awarded for a match drawn. Where match points are equal the winner will be the side with the highest net total of shots (differential system).

If the match points and the net total of shots on a plus and minus basis (differential system) are equal the side with the lowest “total shots against” will be the winner.

ELEVATION, REGRESSION AND MOVEMENT OF PLAYERS.

Centre Competition

- The Bowls Counties Manukau 2010 Inc. event shall be run on a Round Robin format, where every team plays each other. The winner being found as described in the Tournament Winner clause of this Regulation.
- Because of this system the sides for each round **shall stay the same** with the same players playing in the same teams. Therefore, players **may not** inter-change between the Pairs and Fours disciplines but the order of play in Pairs and Fours may be changed before any game.
- Side Personnel are to be recorded on the Side Personnel Sheets provided by the Tournament Director before the commencement of Round 1.

Substitutes for Centre Inter Club Competition.

- Substitutes and changes to original Side Members will be allowed in terms of Bowls New Zealand Regulations.
- Should any player be unable to continue then a substitute member shall play providing that player has not competed in another team or side in this event.

SCORE CARDS

Score cards must be completed **clearly and in full** for every game. The names of all players and the time the game finished must be entered, and the score card must be signed by both skips or players in singles.

ENTRY FEE

- An Entry Fee of **\$105.00**, or such other amount as set by the Centre Board, will be charged for each club side.
- **Withdrawals and Refunds of Entry Fee.** Notification of any withdrawal must be conveyed to the Centre Events Committee, acknowledged by them, 3 days before the event to qualify for a Refund. Notification, regardless of circumstances, outside these requirements will mean that **NO REFUND** will be made.

EVENT DRAW

- Every endeavour shall be made to have the draw on the Centre website 1 week prior to the event.
- **Closing Date** –. Entries received after this shall be at the discretion of the Events Committee and will generally only be accepted to prevent a bye.
