Regulation 6 Centre Powers for Tournaments & Competitions

6.1 Centre Open Tournaments

The Centre Board shall determine conditions of play for all Centre Open tournaments, matches and competitions, which it may conduct for the Centre during the ensuing season.

6.2 Centre Champion of Champion Tournaments

The Centre Board shall determine conditions of play for all Centre Champion of Champion tournaments, matches and competitions, which it may conduct for the Centre during the ensuing season.

6.3 Centre "Restricted" Tournaments

The Centre Board shall determine conditions of play for all Centre "Restricted" events, tournaments, matches and competitions, which it may conduct for the Centre during the ensuing season.

6.4 Matches, Tournaments and Competitions

The Centre Board shall determine conditions of play for all Inter Centre matches and competitions, which it may enter for the Centre during the ensuing season.

6.5 Centre Inter Club Competitions

The Centre Board shall determine conditions of play for all Inter Club matches and competitions, which it may conduct for the Centre during the ensuing season.

6.6 Limitations

The Centre Board reserves the right and shall have the power to vary such decisions if, owing to subsequent circumstances it shall deem such variations to be in the best interests of the sport of bowls

6.7 Consultation with Players

The Board shall review the annual fixtures at the conclusion of each season.

Participants in these events shall be invited to attend a meeting with the Board (or their delegated representatives) to be involved in a consultation process to provide feedback and make recommendations to the Board.

Persons who did not participate may be consulted as well. This may be done in the form of a questionnaire to clubs prior to any meeting with affected players.

The Board reserves the right to decide on competitions and the associated conditions of play for the betterment of bowls in Counties Manukau for current and prospective members. It will however be cognisant of the views and will provide explanations when making decisions that are the minority view.

6.8 Entry to Centre organised Events, Matches and Competitions Limitations

- As a condition of entry into the Tournament, all Players must acknowledge and agree to be bound by and comply with the Laws of the Sport, and the Code of Conduct as set out in Bowls Counties Manukau 2010 Inc Regulation 21
- By completing and registering an entry, players and clubs **agree to be bound by** and to accept this Regulation including these eligibility requirements.
- Entry to the Bowls Counties Manukau 2010 Inc. Centre Tournaments **shall be restricted** to Full Playing members of Bowling Clubs affiliated to the Bowls Counties Manukau 2010 Inc. Centre.
- Entry to team's events (pairs, triples and fours) **shall** be limited to players from the **same club**. This means **No Composite teams allowed**.
