## **NOTICES OF MOTION:**

#### **Bowls Counties Manukau Board**

 That this AGM amends Clause 22.10 of the Bowls Counties Manukau Constitution to change "shall not be entitled to speak or vote"

To:

"shall be entitled to speak but not vote"

T Doell (Waipipi) recommended that the clause remain as is as The Chair already had the authority to allow observers to speak at the AGM.

M Kamphorst advised that any change would not be consistent with the Bowls New Zealand Constitution

**DEFEATED** 

## **Patumahoe Bowling Club**

- 1) That the Membership fee for Bowls Counties Manukau for the 2020/21 year be no more than \$30. This motion was withdrawn
- 2) That the person or body appointed by the Board to manage the business of the Centre according to Clause 21.1 of the Constitution, must be appointed at nil remuneration for the 2020/21 year. This motion was withdrawn
  - 3) That this AGM amends Clause 26.4 of the Bowls Counties Manukau to replace the words "who is a qualified Chartered Accountant" with the words "a suitably qualified person".

Ted Doell (Waipipi) asked how one would define "a suitably qualified person" and stated that the constitution should not be changed.

**DEFEATED** 

Motion from Waipipi "That the Board sought a suitable auditor and called a SGM for delegates to appoint the auditor
Seconded Les Eagleton.

CARRIED

4) That this AGM replaces the word "elect" with the word "appoint" in Clause 18.6.a of the current Constitution of Bowls Counties Manukau.

CARRIED

It was pointed out that we need to be consistent with the Bowls New Zealand Constitution

### Waiuku Bowling Club

1) "We propose that Bowls Counties Manukau(BCM) change the currant inter club format and adopt a competition played throughout the season on a regular basis where teams play in a 'round robin' competition at different venues with finals at the end of the season."

Mark Kamphorst advised that this motion had been submitted at the last AGM but had not been presented.

Concern was expressed as to where this could be fitted into an already full programme.

DEFEATED

## **GENERAL BUSINESS AS NOTIFIED:**

Papakura requested that the following be discussed.

- 1) The Selection Process for the Board.
  - Jan Larsen explained the process as described in the constitution.
- 2) That the BCM Champ of Champ events be played in August 202. Jan Larsen explained why the Champ of Champs had been cancelled.

It was noted that Papakura were disappointed that the champ of Champs had been cancelled. The following also expressed their disappointment: Te Kauwhata, Manurewa, Buckland, Clarks Beach, Patumahoe, Papakura East End. Waipipi supported the Board's decision.

Three notices of motion received from Mark Kamphorst(Waiuku)

 Motion: That a copy of the current constitution, minutes of all AGM and SGM meetings from the 2020 AGM onwards be published on the BCM website in a timely manner. Seconded Les Eagleton(Papakura)

CARRIED

2)	Motion: That all members of Bowls Counties Manukau Board receive a copy of the BCM constitution	
	and that the constitution is complied with"

**DEFEATED** 

3) Motion: That the Board adopt a robust and transparent process, which they will instruct the Selection Panel to use, for all future Board selection recommendations. If necessary guidance as to a process should be obtained from either Bowls NZ or a Human Resource focused organisation. Seconded Ewen McIntyre (Patumahoe)

Mark pointed out that no referees, club captains were consulted, and no interviews given during this year's selection process.

Jan Larsen advised on the process undertaken this year.

**DEFEATED** 

Mark Kamphorst(Waiuku) proposed that a comprehensive review of the Bowls Counties Manukau constitution be undertaken and report back within four months.

Amendment suggested by Ted Doell (Waipipi), seconded by Les Eagleton (Papakura) that the time frame be extended to 12 months in time for the next AGM.
